The School maintained student enrollment while retaining and adding qualified staff to deliver its education program. The School secured funding to assist with schoolwide assessment and evaluation with a refocus on the School's mission and vision. The School continued to focus on academic achievement based on Colorado State standards and financial benchmarks set by Montezuma-Cortez RE-1 School District. The financial benchmarks were achieved in the 2020/2021 school year, and one of the two academic measures - growth, was achieved. Academic achievement, as measured by the Colorado measures of academic learning exam has not been achieved because the assessment was put on hold due to COVID 19.
